NOTICE OF THE 1ST MEETING OF CREDITORS

In terms of section 147 of the Act, the Business Rescue Practitioner wishes to convene the 1st Meeting of Creditors of **BEE Packaging (Pty) Ltd**.

As per the previous communication sent, **BEE Packaging** ("the business") commenced Business Rescue Proceedings in terms of Chapter 6 of the Act on **29th of August 2022**. Furthermore, notification of the appointment of Jaco Durandt as the Business Rescue Practitioner was provided to all affected persons. Confirmation of his appointment was provided by the CIPC on the 29th of August 2022.

In terms of Section 147(3) of the Act, all votes taken during this meeting will be based on a simple majority.
